

RESOLUTION NO. 2011-51

A RESOLUTION OF THE CITY OF GULFPORT, FLORIDA, AMENDING FIRE INSPECTION AND PERMIT FEES IN ACCORDANCE WITH CHAPTER 25 OF THE CODE OF ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on February 15, 2005, City Council passed Ordinance 2005-02, which created Chapter 25 of the Code of Ordinances providing for the organization of the City's fees into one section of the Code; and

WHEREAS, Chapter 25 of the Code of Ordinances provides for various City fees to be adopted and amended by resolution; and

WHEREAS, the City Council has found it necessary to amend fees for fire inspection and permit services provided by the City.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GULFPORT, FLORIDA:

Section 1. The following fees for fire inspection and permit services, referenced in Chapter 25 of the Gulfport Code of Ordinances, are hereby amended as follows:

Each additional inspection after initial inspection.....	\$17.00
Plan review hourly rate.....	\$28.00
Life safety systems (nurse calls, fire doors, smoke detectors, fire alarms, exit graphics, emergency illumination, etc.).....	\$17.00
Fire protection auxiliary power supply.....	\$17.00
Underground storage tanks.....	\$28.00
Smoke stair, smoke removal system.....	\$28.00
Hood and duct extinguishment system.....	\$6.00
Standpipe/sprinkler system.....	\$28.00
Fire pump.....	\$17.00
Spray booth.....	\$17.00
Special fire protection system (Halon, etc.).....	\$17.00
Adult congregate living facilities.....	\$28.00




Section 2. That this resolution shall supersede Resolution 2006-10.
