WHEREAS, City Council authorization is required and a budget amendment is necessary to spend these funds in the current year.

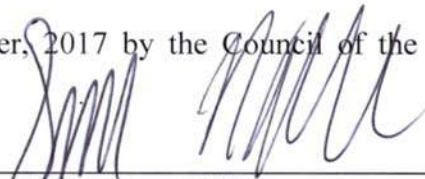

RESOLUTION NO. 2017-96

A RESOLUTION OF THE CITY OF GULFPORT, FLORIDA, AUTHORIZING THE CITY MANAGER TO SIGN A THREE-YEAR LEASE AGREEMENT WITH THE BANCORP FOR THE ACQUISITION OF POLICE VEHICLES; AUTHORIZING A BUDGET AMENDMENT TO ACCOUNT FOR CAPITAL LEASE PROCEEDS AND THE ACQUISITION OF THE POLICE VEHICLES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Council approved a budget with funding for the replacement of up to eleven vehicles this year in accordance with the leasing plan established last year to begin a three-year fleet rotation schedule to ensure maximum residual trade value and minimal maintenance costs; and

WHEREAS, The replacement schedule this year calls for ten vehicles assigned to various personnel in various assignments, including four patrol vehicles, four detective or administrative vehicles, and two pickup trucks; and

WHEREAS, Ten existing vehicles will be traded in; and

WHEREAS, Dodge vehicles will be acquired from AutoNation Chrysler, Dodge Inc. in accordance with pricing established in Florida DMS contract #25100000-16-1, which is effective through 11/16/17; Ford vehicles will be acquired from Bartow Ford based on a piggyback with Charlotte County contract #2015000418, which is effective through 9/30/18 and Mobile police radios will be acquired from Motorola in accordance with pricing established in Florida DMS contract # 725-50-12-1.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GULFPORT, FLORIDA:

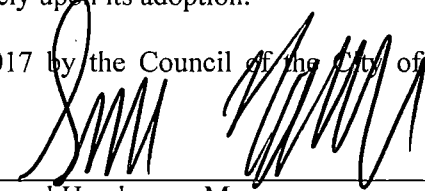
Section 1. The City Council hereby authorizes the City Manager to sign a three-year lease agreement with The Bancorp for the acquisition of ten replacement police vehicles.

Section 2. The City Council hereby authorizes a budget amendment to account for capital lease proceeds and the acquisition of the associated police vehicles as follows:

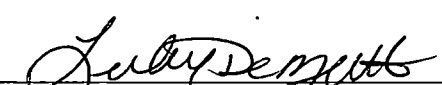

RESOLUTION NO. 2018-09

A RESOLUTION OF THE CITY OF GULFPORT, FLORIDA, PROVIDING FOR A BUDGET AMENDMENT TO ACCOUNT FOR INSURANCE PROCEEDS AND EXPENSE RELATED TO THE REPAIR OF POLICE VEHICLE #531, A 2017 DODGE CHARGER; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Police Department utilizes a 2017 Dodge Charger #531 routinely for local law enforcement and on November 1, 2017, an officer driving the vehicle, while on duty, collided with another vehicle resulting in substantial damage to vehicle #531; and

WHEREAS, Vehicle #531 was appraised and inspected by an insurance adjuster from Gallagher Bassett Insurance on November 13, 2017, and the estimate for repairs from the insurance adjuster was \$23,205.70, for which the City will be reimbursed \$22,205.70 after the \$1,000.00 deductible is applied; and

WHEREAS, The 2017 Dodge Charger #531 is a leased vehicle that is under warranty and repairs had to be completed from the original vendor to ensure continued warranty on this vehicle once repaired. Also, damage to three (3) onboard computers located on the body, transmission, and engine had to be recalibrated, which can only be completed at the Dodge dealer.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GULFPORT, FLORIDA:

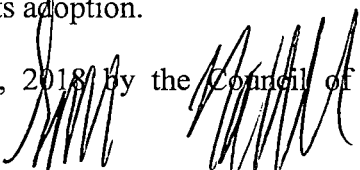

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GULFPORT, FLORIDA:

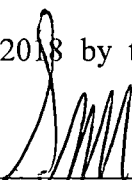

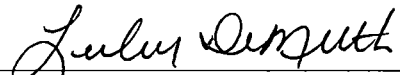

A RESOLUTION OF THE CITY OF GULFPORT, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH FDOT FOR FEDERAL TRANSIT ADMINISTRATION SENIORS AND INDIVIDUALS WITH DISABILITIES CAPITAL ASSISTANCE PROGRAM FUNDS; PROVIDING FOR THE PURCHASE OF A FORD TRANSIT VAN; PROVIDING FOR A BUDGET AMENDMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Gulfport Elderly Mobility Service (GEMS) continues to support the independence and increased quality of life of its participants by providing door-to-door transportation for seniors and disabled residents unable to use conventional modes of transportation; and

WHEREAS, The GEMS program is growing and continues to see an increase in the number of wheelchair and disabled clients; and

WHEREAS, The awarded FDOT grant funding will be used to replace the current 2000 Ford Crown Victoria (capacity of 3 ambulatory passengers) with advanced mileage with a Ford Transit van (capacity of 5 ambulatory passengers and 2 wheelchair passengers).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GULFPORT, FLORIDA:

Section 1. The City Council hereby authorizes the City Manager to enter into an agreement with FDOT for Federal Assistance under the Federal Transit Administration’s Section 5310 Seniors and Individuals with Disabilities Capital Assistance Program Funding for the replacement of a GEMS vehicle.

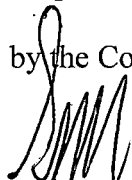

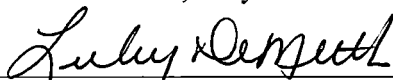

RESOLUTION NO. 2018-34

A RESOLUTION OF THE CITY OF GULFPORT, FLORIDA, AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2017/2018 BUDGET; PROVIDING FOR THE ADDITION OF ONE POLICE OFFICER; AMENDING THE PERSONNEL SUMMARY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The school safety act (Senate Bill 7026), effective 3/9/2018, requires that every public school in the State of Florida have a “school safety officer” assigned; and

WHEREAS, The law allows for alternatives to sworn law enforcement officers at the discretion of the sheriff and the school board superintendent. However, Pinellas County officials have expressed opposition to such alternatives; and

WHEREAS, There are three public schools in Gulfport; and

WHEREAS, Boca Ciega High School (BCHS) already has two officers assigned full time, which complies with the requirements of the new law, Disston Academy is staffed by the Pinellas County Schools Police Department and Gulfport Elementary currently does not have an officer assigned.

WHEREAS, In order to staff Gulfport Elementary School with an officer as required by the law, it is recommended that the City add one police officer position. Although the Police Department could feasibly accomplish the goal by transferring an officer from another assignment, that would result in a decreased level of safety and service for residents.

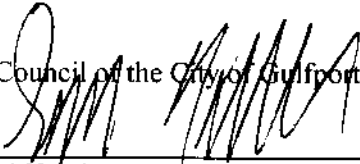
