**SUBJECT:** Second Reading (2nd) Reading of Ordinance No. 2016-06  
Establishment of the Millage Rate for Fiscal Year 2017.

**RECOMMENDATION:** Staff recommends City Council adopt Ordinance No. 2016-06 establishing the millage rate of 4.039 for Fiscal Year 2017.

**BACKGROUND:**

The millage rate for Fiscal Year 2017 is proposed to be set at 4.039 mills. This represents a 7.21% increase above the rolled-back rate of 3.7674 mills. The rolled-back rate is the millage rate that will generate the same amount of property tax revenue as approved for the prior tax year.

**ANALYSIS:**

Total taxable property valuations for tax year 2016/2017 increased in Gulfport by \$58,116,147 when compared to prior year final valuations. This represents an increase of 7.77% over 2015/2016 valuations.

**FINANCIAL IMPACT:**

The proposed millage rate will generate approximately \$3,093,083 in ad valorem revenue to the City in Fiscal Year 2017.

ORDINANCE NO. 2016-06

AN ORDINANCE OF THE CITY OF GULFPORT, FLORIDA, PROVIDING FOR THE AD VALOREM TAX LEVY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016 AND ENDING SEPTEMBER 30, 2017; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the City Council of the City of Gulfport, Florida, has conducted Public Hearings on the final millage rate for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017, in accordance with Florida Statutes; and

**WHEREAS**, the City Council is desirous of adopting the final millage rate of 4.039.

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF GULFPORT, FLORIDA, HEREBY ORDAINS:**

**Section 1.** That a levy of 4.039 operating mills be placed upon the total assessed valuation of real and personal property lying within the City of Gulfport, Florida, and said monies raised by the 4.039 mills shall be used for the general operation of the City of Gulfport for the aforementioned fiscal period. The adoption of 4.039 mills is a 7.21% increase over the rolled-back rate of 3.7674 mills.

**Section 2.** That a certified copy of this ordinance shall be forwarded to the Property Appraiser and Tax Collector of Pinellas County, Florida, together with a request that the aforementioned levy be made by his/her Office on behalf of the City of Gulfport for the Fiscal Year beginning October 1, 2016 and ending September 30, 2017.

**Section 3.** This ordinance shall become effective immediately upon final passage.

**SUBJECT:** Second Reading: Budget Ordinance for Fiscal Year 2017

**RECOMMENDATION:** Staff recommends City Council adopt Ordinance No. 2016-07 establishing and adopting the City of Gulfport's Budget for Fiscal Year 2017, on second (2nd) reading.

**BACKGROUND:**

City Council discussed the Fiscal Year 2017 budget on April 19<sup>th</sup>, May 17<sup>th</sup>, June 7<sup>th</sup>, July 19<sup>th</sup> and held a budget workshop on August 11<sup>th</sup> at which time staff presented the City Council support materials, background information and related costs. During these meetings the City Manager and staff solicited and received comment as it relates to the development of the proposed Fiscal Year 2016 – 2017 budget. As required by the City Charter the City Manager presented his proposed Fiscal Year 2016 – 2017 budget on July 15<sup>th</sup>, 2016.

The City Manager's Fiscal Year 2016-2017 Operating Budget must also fulfill the requirements of Florida Statute 166.241 that stipulates that the amount available from taxation and other sources, including amounts carried over from prior fiscal years, must equal the total appropriations for expenditures and reserves. The budget for Fiscal Year 2017 was prepared using revenue and expenditure estimates that are available at this time. Surpluses and shortfalls are cumulative in the sense that any individual year's surplus or deficit flows into the next year's fund balance, thus carrying a current year's balance forward.

The General Fund balanced budget of \$11,460,000 continues to provide the residents of the City of Gulfport the traditional level of day-to-day services they have become accustomed to.

**ANALYSIS:**

The Fiscal Year Operating Budget of the City of Gulfport balances the public service needs of the community with the fiscal resources of the City. It is intended to achieve the objectives established by the Council for the next fiscal year.

The City has made a commitment to fiscal responsibility, and in doing so, is required to adopt a balanced operating budget as the cornerstone of this commitment. The City has set forth via Resolution that the City will maintain an Unreserved General Fund Balance at a level not less than twenty-five (25) percent of previous fiscal year's General Fund expenditures. To the extent that unreserved General Fund balance exceeds twenty-five (25) percent of previous fiscal year's General Fund expenditures at the Fiscal Year end, the City may draw upon the fund balance as approved by City Council.

The City of Gulfport's annual budget is structured to support the services required to maintain a full service city of more than 12,000 residents. The City of Gulfport's Fiscal Year 2016-2017 provides for a staff of 123 full-time and 60 part-time employees, of which 52.5 are public safety related. The employees provide services which include police, fire, community development, code enforcement, water & sewer utilities, sanitation, street maintenance, library, marina, cultural facilities, events, and parks & recreation.

**FINANCIAL IMPACT:**

As required, included within the accompanying ordinance is a summary of the budget for Fiscal Year 2017 including details of revenues, expenditures and fund balances.

**City Council Workshop Meeting Minutes**  
**Thursday, August 11, 2016**

---

A Workshop Meeting of the Gulfport City Council was held on Thursday, August 11, 2016, in the City Hall, City Council Chambers, located at 2401 - 53<sup>rd</sup> Street South, Gulfport, Florida.

Samuel Henderson, Mayor, called the meeting to order at 6:00 p.m. All council members were present.

**1. Public Comment.**

Betty Pierson, 2760 Upton Street S., spoke about repairing and adding tennis courts in the City.

Chuck Broich, 2666 45th Street S., asked about how a potential housing crash might affect the budget if property values decline with Mayor Henderson advising this would affect the budget.

Scott Linde and Barbara Banno, on behalf of the Gulfport Merchants Association, provided images of bus shelters; inquired about TIFF funding regarding art projects relating to bus shelters, and spoke about trolley stops with a gecko theme; the welcome center and asked that the City's welcome flags be updated and suggested Gulfport kiosks be implemented that would provide a schedule of events happening in the City.

Margarete Tober was recognized by Mayor Henderson and provided the City's history regarding the sewer system repairs/updates; loans and financing and provided suggestions for amenities in the Northeast corridor; code enforcement and the sculpture garden completion.

**2. Discussion Proposed Fiscal Year 2016-2017 Operating Budget.**

City Manager O'Reilly thanked City Staff for their assistance on the budget and provided information regarding any potential property value decline and said the City is cognizant of long term effects of proposed expenditures on the City Budget. City Manager O'Reilly provided and reviewed a PowerPoint presentation on the budget.

Councilmember Liedtke asked if the City could fund at least one new PSTA bus stop for Ward I next to Town Shores and City Manager O'Reilly said he will follow up on this request at a future meeting. Councilmember Liedtke said he would like to see an informational screen display inside the Casino window which would provide a schedule of City events and City Manager O'Reilly advised he will add this to the list.

Councilmember Roman said she believes the City has made extensive progress on the water/sewer repairs; spoke on the 60th and Gulfport Boulevard pocket park; recommended having a community forum regarding the senior center remodel; provided information regarding grants by the Florida Coastal Management Program as relating to Clam Bayou; equipment to use during rain events such as a pump truck; the possibility of implementing a lateral pipe grant program for residents; solar energy as a long term objective and contributing to the Gulfport Pirates Football Program. Recycling in the City; See-Click-Fix Program and street pavers/bricks

being utilized for re-paving were discussed by City Manager O'Reilly and Council Member Roman.

Councilmember Brown said she is in favor of repairing the Chase Park tennis courts; a proposed linear park behind Boca Ciega Yacht Club; improving sheet flow at the terminal end of streets; she is in favor of the mooring field and oyster fields; re-designing the park in Clam Bayou into a flat ground and asked for the costs of an additional sanitation and street crew and questioned the need for extra code enforcement and planning staff.

Vice Mayor Fridovich said he would like to look into the cost of a part-time code enforcement officer; he is in favor of the mooring fields; he is appreciative of the Casino becoming profitable and this was discussed by City Manager O'Reilly; as well as an overview of accomplishments made by current City Staff. Vice Mayor Fridovich said he is in favor of oyster beds and solar panels and commended City staff on the progress of the Marina and this was explained by City Manager O'Reilly. He stated he is in favor of the bus stop shelter and would like to see businesses paint murals on their buildings.

City Manager O'Reilly discussed the options and costs of hiring additional City staff.

Mayor Henderson thanked City staff for their efforts with the budget; he asked for council consensus to reapply for the grant for the bike trail; and there was no objection by council. City Manager O'Reilly asked for permission to budget for a re-design/relocation plan of the skate park. There was an objection from Council Member Liedtke to the skate park proposal. A proposed location for the skate park as well as costs were discussed and there was a consensus to review the costs for a re-design for the skate park. Mayor Henderson suggested that the City add a streets department in the upcoming years; asked if funds could be allocated to the Merchant's Association for projects and this was discussed by City Manager O'Reilly. Mayor Henderson said he is in favor of tennis court renovations in Chase Park; he would like dual recycling trash bins and bike racks to be included in the final phase of the Shore Boulevard Improvements Project and said he is in favor of a redesign at Osgood Point and the Peninsula Park in the future with possible camping amenities.

In response to a question from Vice Mayor Fridovich, City Manager O'Reilly advised that Scout Hall is being utilized.

Mayor Henderson continued by saying he appreciated Ms. Tober's comments on Ward IV parks; and was in favor of Tomlinson Park improvements.

Councilmember Liedtke asked for a report regarding the foreclosure registry.

**3. Adjournment.**

Motion by Vice Mayor Fridovich, second by Councilmember Brown to adjourn.

## **Regular City Council Meeting Minutes**

### **Tuesday, August 16, 2016**

---

The Regular Meeting of the Gulfport City Council was held on Tuesday, August 16, 2016 in the City Hall, City Council Chambers, located at 2401 - 53<sup>rd</sup> Street South, Gulfport, Florida.

Samuel Henderson, Mayor, called the meeting to order at 7:00 p.m. The invocation was given by Councilmember Daniel Liedtke followed by the Pledge of Allegiance.

#### **Roll Call:**

Present were Councilmembers Christine Brown, Daniel Liedtke and Yolanda Roman; Vice Mayor Michael Fridovich; Mayor Samuel Henderson, City Manager James O'Reilly; City Attorney Andrew Salzman and City Clerk Lesley DeMuth.

#### **Presentations:**

Mayor Henderson presented a Proclamation to Friends of Strays in recognition of International Homeless Animals' Day.

Mayor Henderson presented the Spirit of Gulfport Award to West Dupes.

#### **1. Public Comment.**

April Thanos, 5850 27<sup>th</sup> Avenue S., advised she had spoken at the County Commission Meeting about money for landscaping along Gulfport Boulevard, and commented on the new parking signs.

Cindy Davis, 2590 45<sup>th</sup> Street S., asked about the status on the offer of a donation of high tech police vests.

Richard Fried, 1822 ½ 56<sup>th</sup> Street S., spoke on council's unwillingness to make a difference and their being held silent by Home Rule; advising he would take the remainder of his three (3) minutes of speaking time in silence.

Mayor Henderson recognized Margarete Tober who spoke on the Gulfport Neighbors upcoming Welcome to Gulfport event.

Tim Spencer, 5857 26<sup>th</sup> Avenue S., asked for a status on the city's app., suggested the city have additional EV (electric vehicle) chargers, brought forth concerns of items for trash pick-up not being within the city's guidelines, and expressed his opinion that council does listen.

Mayor Henderson recognized Stan Kreuter who spoke on issues with city signage and questioned the opening, closing and parking times in city parks.

#### **2. City Manager Report.**

City Manager O'Reilly, in response to items brought forth during Public Comment, advised:

- council did extend the parking time in Veterans Park to accommodate restaurants and staff parking and all parks are posted with opening and closing times; which information is also available on the city's website;
- signs were installed on 59<sup>th</sup> Street to address the parking issue and subsequently they were removed by vandals; the city is investigating this and the signs will be replaced;
- there has been preliminary discussions regarding landscaping along Gulfport Boulevard, but there are right-of-way issues and plant materials can only be placed on public property;

Councilmember Liedtke reported on the upcoming Tampa Bay Beach Bums volleyball tournament to raise money for the Gulfport Pirates; asking City Manager O'Reilly if David Mather could look into setting up an online court and pavilion reservation system, the Beach Bums have approximately six Sundays reserved for 2017 and said he would like to meet with the Gulfport Women's Volleyball Group to coordinate schedules so that they always have a place to play on Sunday. In response to questions, City Manager O'Reilly advised the City is only involved in a commercial PACE Program; none of which have been written and explained why the city did not do a residential PACE Program. Mayor Henderson suggested having a presentation on the PACE Program and there was no objection by council. Councilmember Liedtke said he read that the City of St. Petersburg is still dumping and asked if they had met all protocols to which City Manager O'Reilly said they are dumping into Tampa Bay, but city protocols were met and advised the City has reported itself on Friday as it reached the point of discharge.

Mayor Henderson thanked City Staff for their work during the storm event and thanked the City on behalf of the business community for Gecko Fest going forward.
