

RESOLUTION NO. 2020-07

A RESOLUTION OF THE CITY OF GULFPORT, FLORIDA, ACKNOWLEDGING THE REMAINDER OF NATIONAL MEDAL FOR MUSEUM AND LIBRARY SERVICES GRANT AWARD FUNDS; ACKNOWLEDGING THE AWARD TO THE GULFPORT PUBLIC LIBRARY OF A COMMUNITY PROJECT GRANT FROM THE FLORIDA HUMANITIES COUNCIL; ACCEPTING A LETTER OF COMMITMENT TO THE GULFPORT PUBLIC LIBRARY AND THE EXPENDITURE OF BEQUEST FUNDS; PROVIDING FOR THE ASSOCIATED BUDGET AMENDMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Gulfport Public Library won the prestigious National Medal for Museum and Library Services Award in 2019. Part of the award was a \$10,000.00 grant to be expended by September 30, 2020. In FY 2018/2019 the Library expended \$2,319.05 leaving \$7,680.95 to be reflected and expended in the current FY 2019/2020 Budget; and

WHEREAS, The Gulfport Public Library has been awarded a Community Project Grant from the Florida Humanities Council as reimbursement of the annual ReadOut Program in the amount of \$3,500.00; and

WHEREAS, The Family of Juliette Mastry Pastirjak, a longtime volunteer at the Gulfport Public Library, has submitted a letter of commitment for the purchase of children's library shelving as a memorial befitting their mother in the amount of \$7,653.27.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF GULFPORT, FLORIDA:

Section 1.

The City Council hereby acknowledges the remainder of National Medal for Museum and Library Services Grant Award funds, \$7,680.95, in the FY 2019/2020 Budget; acknowledges the award of a Community Project Grant from the Florida Humanities Council to the Gulfport Public Library in the amount of \$3,500.00; accepts a letter of commitment to the Gulfport Public Library from the Juliette Mastry Pastirjak Family and the expenditure of bequest funds for children's library shelving in the amount of \$7,653.27.

Section 2.

The City Council hereby authorizes the associated budget amendments as attached hereto and made a part of this Resolution as Exhibit A.

Section 3.

This resolution shall become effective immediately upon its adoption.
